Registrations must be made in writing. They are binding and are considered in order of entry at e.u.[z.]. The number of participants is limited. Upon your registration you shall receive confirmation of your registration, a map with directions, and the invoice.

Cancellations must be made in writing. Decisive is the timely dispatch (date of the postmark). Please note that cancellation fees apply*), unless a substitute participant is provided after consultation with the organizer. If a registered participant does not appear for the event, the full attendance fee will be charged. For changes participation on a later seminar date a fee of 50 Euro will be charged.

Cancellation of events: e.u.[z.] reserves the right to cancel events because of an insufficient number of participants or other reasons. Registered participants will receive notice. In this case, e.u.[z.] is only bound to refund any attendance fees already paid. In exceptional cases, the organizers reserve the right to change lecturers and/or make changes to the program. In any case, liability is exclusively limited to the attendance fee.
